ORDINANCE 16-10

**AN ORDINANCE OF THE TOWN OF BOONTON, COUNTY OF MORRIS, STATE OF NEW JERSEY
AMENDING CERTAIN PORTIONS OF THE TOWN CODE REGARDING BUS STOPS; TAXI STANDS**

BE IT ORDAINED by the Town of Boonton, in the County of Morris and State of New Jersey as follows:

SECTION 1. Chapter 289-19, Section 289-19, entitled Bus stops, of the Revised General Ordinances of the Town of Boonton is hereby amended and supplemented to now read as follows:

The locations described are hereby designated as bus stops. No vehicles other than an omnibus, picking up or discharging passengers, shall be permitted to occupy said location between the hours indicated.

Street A	On Main Street, westbound on the northerly side at:	All
	1. Hill Street – (near side) Beginning at the northerly curbline of Hill Street and extending 85 feet westerly therefrom	
Street B	On Main Street, eastbound on the southerly side at:	All
	1. Hill Street – (far side) Beginning at the prolongation of the northerly curbline of Hill Street and extending 60 feet westerly therefrom	
Street C	On Washington Street, eastbound on the southerly side at:	All
	1. Lathrop Avenue – (far side) Beginning at the prolongation of the westerly curbline of Lathrop Avenue and extending 80 feet easterly therefrom.	
	2. Monroe Street – (near side) Beginning at the westerly curbline of Monroe Street and extending 85 feet westerly therefrom.	
Street D	On Myrtle Avenue northbound on the easterly side at:	All
	1. Main Street – (near side) Beginning at point 175 feet from the northerly curbline of Main Street and extending northerly 100 feet therefrom.	
	2. Vreeland – (near side) Beginning at the southerly curbline of Vreeland Avenue and extending 105 feet southerly therefrom.	
	Fulton Street – (near side) Beginning at the southerly curbline of Fulton Street and extending 105 feet southerly therefrom.	
Street E	On Myrtle Avenue southbound on the westerly side at:	All
	1. Fulton Street – (near side) Beginning at the southerly curbline of Fulton Street and extending 100 feet southerly therefrom.	
	2. Main Street – (near side) Beginning at point 530 feet from the northerly curbline of Main Street and extending northerly 100 feet therefrom.	
Street F	On West Main Street, eastbound on the southerly side at:	All
	1. Hawkins Place – (far side) Beginning at the prolongation of the southerly curbline at Hawkins Place and extending 135 feet southerly therefrom.	

SECTION 2. This Ordinance shall take effect immediately upon final passage, approval and publication as required by law.
