**RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF BOONTON, COUNTY OF MORRIS AND STATE OF NEW JERSEY, AUTHORIZING PARKING ENFORCEMENT OFFICER TRAVIS KNOEDLER TO ATTEND THE PASSAIC COUNTY POLICE ACADEMY TO RECEIVE TRAINING AS A CLASS 2 SPECIAL LAW ENFORCEMENT OFFICER**

**WHEREAS**, the Town has need for a Class 2 Special Law Enforcement Officer, to support and augment public safety in the Town of Boonton; and

**WHEREAS**, Parking Enforcement Officer Travis Knoedler has been selected to attend the Passaic County Police Academy, effective February 23, 2021; and

**WHEREAS**, Parking Enforcement Officer Knoedler is desirous to attend such training, and continue in his employment with the Town of Boonton; and

**WHEREAS**, it is the desire of the Mayor and Board of Aldermen to send Parking Enforcement Officer Knoedler to the Passaic County Police Academy to receive training as a Class 2 Special Law Enforcement Officer, and achieve that status; and

**WHEREAS**, such fee for the Passaic Police Academy shall be paid by the governing body; and

**WHEREAS**, funds are available for this purpose not to exceed \$3,800.00; and

**NOW THEREFORE, BE IT RESOLVED** by the Mayor and Board of Aldermen of the Town of Boonton, County of Morris and State of New Jersey, that Parking Officer Travis Knoedler is hereby authorized to attend the Passaic County Police Academy, to be trained and hold the position of Class 2 Special Law Enforcement Officer with the Town of Boonton.

**BE IT FURTHER REVOLVED** that the Mayor and Town Clerk are hereby authorized to take all such actions necessary to finalize said appointment, and in support of the expressed attendance date.
