INSTRUCTIONS

1. Read Petition carefully and fill in all blank spaces where required
2. The petitioner must sign in his/her own handwriting, giving both their residence and post office address.
3. The person in whose presence the Petition was signed must sign within the Petition and also make the affidavit before an officer authorized by law to take affidavits
4. Candidate(s) must sign the Oath of Allegiance and Certificate of Acceptance, stating that they are qualified for the office and is a member of the stated political party.
5. One or more petitions may be circulated, and one or more petitions may be filed on behalf of the candidate.
6. Signers must be qualified voters and reside in the political subdivision for which the candidate stands for office
7. File Petition with the Municipal Clerk not later than 4:00 p.m., 64th day prior to the date of the Primary Election.

WARNING

This petition may be used as a joint Petition for Mayor and Councilmen at large, but may not be used as a joint Petition for a Ward Councilman and others unless signature sheets are attached clearly indicating the Ward signers

NUMBER OF SIGNATURES REQUIRED

Equal to at least 5% of votes cast for your political party at last Primary Election for members of General Assembly for your Municipality and/or ward. The number of valid signers of the petition should equal or exceed the number required by law. Contact your Municipal Clerk for the number of signatures required for your petition.

RESIDENCY AND REGISTRATION OF CANDIDATE(S)

No person shall be eligible to be a Candidate unless (1) Person is a Registered Voter in Municipality and/or Ward (2) Person was or will be a resident of Municipality and/or Ward one year prior to date of next General Election
